

AUTUMN SCHOOL HOLIDAY PROGRAM

Our Autumn school holiday program is a 5 day course which runs daily 9 am—4 pm.

Children are allocated a horse and, under close supervision are responsible for the grooming and general care of the horse for that week. The children are taught riding skills and are taken on supervised trail rides.

Each morning of the program a safety talk is given by one of our instructors on the various safety aspects of working around horses.

If you wish your child to participate in one of our holiday programs please fill out the form on the reverse of this page and return with a **deposit of \$60.00 and the enclosed Liability Waiver** to hold a place for your child. No phone bookings can be taken.

Due to the popularity of our programs we will be allocating places strictly **in order of receipt of your deposit.**

Our horses.

We have a large group of reliable and well trained horses available to suit all standards of riders.

Our Instructors.

We have a dedicated and experienced group of instructors. Qualifications include Tafe, agricultural college, Equestrian Federation of Australia N.C.A.S and Bachelor of Education. Note that all instructors undergo regular in house training including safety aspects of horsemanship.

Daily Routine.

The children are divided into 3 groups according to age and experience. There are no more than 10 children in a group. They are allocated their own horse for the week and learn about grooming, feeding and caring for their horse. They are able to ride twice daily. Each group has one instructor and an assistant.

Children will have the chance for a break for morning and afternoon teas, and also for lunch. We encourage regular drink breaks, especially in the hot weather. We also encourage nutrition and ask that parents ensure their children eat a good breakfast each morning before they attend our program.
